TERMS AND CONDITIONS OF TRADE - CUCINA FOODS LIMITED

1. INVOICES shall be raised in respect of goods purchased and issued with the goods.
2. DELIVERY shall normally be within 48 hours unless otherwise requested.
3. CLAIMS must be made within 7 days quoting relevant invoice number.
4. DUE NOTICE of changes in price and charges shall be issued however Cucina Foods Ltd reserves the right to make reasonable alterations to prices without notice.
5. PAYMENT is due 7 days from date of invoice. OR 14 days when paying by initiated direct debit.
6. OVER DUE ACCOUNTS: Cucina Foods Ltd reserves the right to make a penalty interest charge of 2% per month on the overdue amount if payment is not received within 30 days following due date, and to charge cost of recovery and collection by our debt collection agency.
Where payment is overdue, future orders may be held until such time as the account is current.
7. OWNERSHIP of the goods shall not pass from Cucina Foods Ltd to the purchaser until the purchase price and other payments due from the buyer are paid in full.
8. PRIVACY ACT 1993: Cucina Foods Ltd retains the right under the Act to request information on credit customers from credit agencies or other referees and in the case of debtors who fail to meet their obligation to provide details of debtors and their debts to our debt collection agents.
9. Any change in ownership of the applicant’s business shall be promptly notified to Cucina Foods Ltd.
